

C.1 Comments from the Chairperson of Council – 2019

2019 was a year of some significant changes in the life of City View United Church. Yet, along with those changes, we continued to move forward with the exceptional work done by our dedicated staff and volunteers. This annual report is a tribute to our entire congregation, and to the Christian vision to which we are all called.

During the year, we had the retirement of the Reverend Dr. Karen Boivin as our minister, after three years of ministry at City View. During her time here, she implemented many innovative ideas, which significantly added to the strengths of our Sunday worship services. She also challenged members of Council to be strategic, as we consider "Big Ideas" surrounding possible future uses of our land, our buildings, and our church programs. We were sad that she left, but we are thankful that she has given our church a solid foundation on which to move forward as we call our next minister.

As well, we had the retirement of our music director and organist, Jiri Hlavacek, after a dedicated and decades-long career of service to City View. His impact on our music ministry and our Sunday worship services will be remembered with fondness and gratitude.

Those two developments resulted in additional work that was faithfully taken up by dedicated church members. A search committee found a new music director and organist, Noah Landers. We have been enjoying Noah's musical talents and leadership since September.

The Ministry and Personnel Committee recommended that Reverend Anne Montgomery join us as our part-time supply minister as we commence our search for a new full-time minister. The congregation welcomed Rev. Anne back with open arms in July and are thankful for her calm, steady leadership in these changing times.

Our search for a new full-time minister required a Community of Faith profile to be produced; that task was faithfully completed by Harry Bender, Steven Bergman, Peter Charboneau, and Bruce Petrie. Furthermore, a search committee had to be formed and we thank Steven Bergman, Joanne Lewis, Kim Benjamin, Heather Kritsch, and Harry Bender for taking on this important task. We are all hopeful that a new full-time minister will be called in early 2020.

Lastly, in March, we welcomed Megan Baker as our new Sunday School Coordinator, providing leadership and instruction to our energetic group of Sunday school students.

We are thankful for the continued dedicated work of our staff including Mary-Lynne Harvey for her leadership and organization in the Office. Patrick Pearson has been instrumental in keeping the church clean and in a state of good repair, and Veronica Moore continues to carefully maintain the financial books.

While managing all of that change, our dedicated volunteers continued to achieve all of our regular goals: the annual Christmas Hamper and voucher program; Camp Awesome Children's Summer Camp; art supplies to children in Iqaluit; the Snowflake Bazaar; and special events organized by the Communications and Events Committee. In particular, I would like to acknowledge the efforts of everyone involved in organizing both Rev. Karen's retirement luncheon and Jiri's retirement banquet; both events were fitting tributes to two lovely people.

C.1.1 "Big Idea" Committee

Since the adoption of our Mission and Vision statements, collectively, we have been working through ways to move forward with them. How do we take those next steps? In June 2018 Council accepted an approach to invite a small cross section of members of CVUC to join them for a morning "Big Idea" workshop.

The Big Idea workshop came out with three broad notions to explore further:

- 1) Helping the Community as a 'community center'
- 2) Redevelopment of the land/building
- 3) Joining with others

With these broad notions as a basis, Council formed the Big Idea Committee.

In January 2019, we hosted – at the invitation of Council and Rev. Karen – six other local United Churches at City View for a round-table discussion about ideas. Thanks to Peter Fortura and Rev. Karen for organizing this. Shortly after, during the spring months of 2019 Rev. Karen and Dave Carney did a lot of outreach into the community to get a flavour for some ideas. They talked with 14 local groups, faith organizations, and our city councillor. Finally, in the late spring we asked you – the congregation – for your input on a Big Idea.

In early May, we held a town hall meeting, where we "played back" what we had heard. This culminated with a congregational meeting in late May, where the congregation agreed on a Big Idea through a congregational vote. The agreed upon Big Idea:

Explore community partnerships and redevelop part of the CVUC space to support community groups.

Through all of this, members of the Big Idea Committee met with various groups to establish community relationships as a starting point for formalizing partnerships. To support this process, CVUC is actively exploring the creation of a Community Liaison Officer.

Unfortunately, with the retirement of Rev. Karen in June, and the need to search for a new Minister, activities with the Big Idea Committee were paused. However, the direction has not been paused. With 2019 completed, and on the eve of a new Ministerial call being put forward, the intent is to unpause the Big Idea Committee, and continue pushing forward with the agreed upon "Big Idea" approach.

I'd like to thank the members on the Big Idea Committee - Dave Carney, Heather Kritsch, Karl Tibelius, Peter Fortura and of course Rev. Dr. Karen Boivin – for their work and support in 2019.

I continue to invite you to offer any input or "big ideas" you may have; or any community needs that you feel CVUC should be looking at. Feel free to contact myself, or anyone else on the committee to share your thoughts.

Stay tuned for more information from the Big Idea Committee in 2020.

C.2 Congregation Worship and Education Committee

Worship & Education Committee

This committee's primary focus is as follows:

- Coordinate Sunday worship services, including: service readiness, ushers, readers, sound, decorations, communion, special music;
- Coordinate youth interaction, such as Sunday school, youth group, nursery;
- Coordinate other literature of spiritual learning; and encouraging stewardship of the Church.

C.2.1 Sunday Worship Services

The committee met every few months offering input to help Rev. Karen plan out the Services. Some items to note with the Services:

- We fully integrated the usage of the video screens into the Services, projecting hymns, YouTube videos, and slide shows. (Thank you to Kim Benjamin who is working behind the scenes with Rev. Anne to provide the slide content.)
- We held themed Services, such as the team jersey Service and a drumming Service.
- We asked that the Youth do the Bible reading once a month.
- In the fall, we tried a new approach (at least for City View) for communion by intinction, with the pulling of the bread pieces from a central loaf. Feedback was positive. Thanks Rev. Anne for introducing the new approach, and to Judy and John Wessels for continuing to coordinate the communion preparations.
- The kids' table at the side continues to see good use during the first part of the Service.

As a committee, we continue to reflect on how to respect the traditions and customs that the City View congregation has used for many years, while looking to inject areas of contemporary Worship practices. We invite you to share any items with myself or the committee that you would like to see in our Service.

After many years of service Heather Cummings stepped back from coordinating the Sunday Bible readers. Thank you for your help over the many years. In the absence of another person taking over, we will continue to utilize a sign-up sheet. Thank you to those that continue to volunteer; and feel free to sign-up to read any time.

We continued to utilize a sign-up list for weekly ushers. Thank you to all of you who signed-up and volunteered your time to greet, meet and assist our Congregation in this role.

In June of 2019 we commemorated the retirement and said good-bye to Rev. Dr. Karen Boivin. We also welcomed, in August, on a part-time and interim basis Rev. Anne Montgomery. The transition occurred very smoothly, and I thank committee members and Rev. Anne for their cooperation.

Worship Services over the year have occurred as past years, including the Maundy Thursday, Good Friday, and Easter Service; a Blue Christmas Service; the annual Choir Candlelight Service. Of note, the Good Friday service was a joint Service with Faith Lutheran, Julian of Norwich and City View. The three Churches began outside Faith Lutheran on Meadowlands, walking the stations of the cross and ending at City View for the Services.

Like last year, we held only one Christmas Eve Service in the early evening, targeted to families. It was well attended and was well received.

In 2019 we also said good-bye to Jiri Hlavacek's musical leadership, as he retired from City View. Jiri's musical leadership was legendary. Prior to Jiri's retirement, we were all deeply saddened by the passing of Stanja Hlavacek. Jiri, we wish you well.

Jiri left big musical shoes to fill. We were fortunate that we found Noah Landers. Noah has seamlessly stepped into City View's musical leadership and is doing a superb job. Welcome and thank you Noah. Heidi Li continued to offer her musical ministry during the summer months of July and August, when asked. Thank you to Jeannette Pole who sits on this committee and gives her input and offers us insights into Choir activities. And thank you to the wonderful choir members who offer their ministry of song during our Services.

This past year we once again had a pizza lunch to decorate the Sanctuary for Christmas after Service. We had a few dozen people attend and help with the decorations. This included adults and a gaggle of kids. It was a lot of fun watching the kids put bulbs on the Christmas trees, organize tinsel and garlands; an all-round good time!

Finally, a special thank you for all of those that work to keep the Worship Services running, including the many Ushers, Communion helpers, Readers, Offering collection personnel, and the Audio/Visual group members. I know there are many others that do less obvious, but nonetheless important things (i.e.: flowers, banners, decorations). Thank you! It's our collective effort that makes Worship Services at City View engaging, thoughtful and entertaining.

C.2.2 Youth Interactions: Nursery, Sunday School, Youth Group; Camp Awesome

City View is blessed to have the continued input from many people in support of our kids and youth.

In the spring of 2019, we welcomed Megan Baker as our new Sunday School and Youth Coordinator. Megan has engaged the kids and our young people and continues to plan out weekly lessons and activities, aligned with the Service theme, for the Sunday School. In addition, Megan coordinated an Easter pageant with the kids, as well as a contemporary Christmas pageant. Thank you, Megan!

Among the Christmas Season activities, the kids helped decorate friendship baskets and create Christmas tags. Thanks to the generous support of the congregation through the purchase of Christmas tags, almost \$600 was raised to send creative toys and craft supplies to children in Iqaluit this Christmas.

They were gratefully received and were distributed through the local food bank to more than 50 children. Thanks to Chris Tibelius for spear-heading this campaign.

Along with myself, Megan has been assisted on Sundays by Heather Kritsch as teachers, along with Chris Tibelius from time to time. Thank you for your continued help and support. We are always looking for helpers down in the Sunday School; even if it's one Sunday a month.

After many years of service, Eleanor Henderson decided to step back from coordinating the Nursery supervision. Thank you, Eleanor, for those many years of service. In the absence of anyone taking over, we have been utilizing a sign-up list. We continue to have a small number of very young visitors each week, so I do encourage you to sign-up if you can.

Overall, the Sunday School had a core number of kids. Average attendance was between 8 and 9 every week, with approximately 15 children attending on a semi-regular basis. We continue to look for support from the Congregation to be teachers or extra helping hands.

We celebrated the coming of summer (and some would say the end of school) with the end of year picnic in June. It featured food, drink, and games for the kids. Thank you to the volunteers who barbequed, and prepared other food. Later in the fall, during Halloween, the kids and youth partook in Halloween games. The "pumpkin popping", "cooking", and "mummy wrap" were favorites. Thank you for the support.

I will note that there are a small number of 'kids' that are entering the youth group age. We are actively exploring ways to accommodate the older cohort into our Sunday school activities.

Finally, we were blessed to have Jennifer Landry lead our involvement with Camp Awesome. Camp Awesome is a week-long Christian day camp program sponsored by the Eastern Ontario Outaouais Regional Council of the United Church of Canada. This past year's Camp Awesome occurred in July. Although attendance was lower as compared to previous years, the children and volunteers had fun.

C.2.3 Other Literature and Spiritual Learning

There is the ongoing Bible Study meeting that occurs weekly. We continue to be blessed with the Library in the Friendship room that has many books available for usage on a weekly basis.

Without the continued inputs and time of the Worship & Education Committee members, and of course the ongoing Spiritual Leadership of Rev. Karen, and in the later part of the year, Rev. Anne, we would not have the Worship and Education experiences we have today. The continued focus of this committee going into 2020 will be to help foster a positive Worship experience, to engage our kids and youth, and offer means to learn God's Word through various activities.

C.6 Ministry & Personnel Committee

The M&P Committee is basically the Human Resources department for CVUC. We consult with our staff on a regular basis to discuss any issues or matters related to working conditions or work relationships. The committee is responsible for interpreting and changing job descriptions, hiring staff, issuing service contracts, making recommendations to Council on compensation, and coordinating the annual reviews of our staff. The committee is also responsible for hiring pulpit supply and temporary help for when staff are on vacation. 2019 has proven to be an unusually busy year.

After the resignation of Emily DeWolfe, our Sunday School and Youth Coordinator, in April 2018, we reviewed the position description with the minister and the Sunday School leadership and decided to focus our efforts on recruiting a Sunday School Coordinator at this time and then expand that role to include a Youth Program as we have kids ready to move up into that youth age group. Working with Steven Bergman and Chris Tibelius, we were able to recruit and hire **Megan Baker**. Megan took on the Sunday School Coordinator role as of March 1, 2019. *Thank you, Megan, you have been a real asset to our Sunday School program ever since.*

On March 29, **Rev. Dr. Karen Boivin** submitted her notice to retire effective June 30, 2019. We were surprised and saddened by her announcement. Rev. Karen had done a lot since starting at CVUC on August 22, 2016. In addition to supporting our worship and pastoral needs, she was heavily involved in our Big Ideas project and was a strong proponent of installing screens in the sanctuary to enhance our worship services. A farewell luncheon was held on June 16, catered by Queenswood United Church Catering. The congregation presented Rev. Karen with a lap quilt made by Isabel Bender and a cash purse as mementos of her time with us. Thank you to Larry Dobson, Mary Lynne Harvey, Peter Fortura, and Steven Bergman who were instrumental in organizing this event.

Given Rev Karen's retirement announcement, Council directed M&P in April to look for a supply minister to fill in while we develop the Community of Faith profile and search for a new minister. At the May 8 Council meeting, Council accepted M&P's recommendation to hire **Rev Anne Montgomery** effective July 1 as our supply minister for a 6-month term with a 2-week cancellation notice should we find a new minister during this term. She will be working 30 hours per week or ³/₄ time. In December, having not yet found a new minister, we renewed her appointment for another 6 months until June 30, 2020, again with a 2-week cancellation notice. *Thank you, Rev Anne, for taking on this role. We have really appreciated your leadership and insights in Worship and Pastoral Care during this interim period.*

On May 31, **Jiri Hlavacek**, our Music Director and Organist for 34 years, submitted his letter announcing his retirement effective August 31, 2019. We were saddened with this news, even more so since his wife, Stanja, had just passed away in March. We held a Retirement Banquet for Jiri at the Tudor Hall on September 20 with over 130 people in attendance, including former choir members, former ministers, and members of the Nepean Concert Band joining with us to celebrate Jiri's long career with us. Thank you to Larry Dobson, Mary Lynne Harvey, Peter Fortura, Dave Carney, Carla Winchester, Janet Hrnchiar, and Phyllis Potts who helped in the planning and organizing of this event. Thanks too to Heidi Li, the CVUC choir, and the Nepean Concert Band who provided the entertainment for the evening. And a big thank you to Council and the CVUC choir for authorizing funding to subsidize the cost of the meals at the Tudor Hall, and for their gifts of Travel vouchers to commemorate Jiri's music leadership with us. On September 22, Jiri played his last Sunday service with us. This marked his 34-year milestone as organist with CVUC and of course, we celebrated with cake afterwards.

In June, we set up a search team for a new Music Director/ Organist, consisting of Jean Nielsen, Janet Hrnchiar, Phyllis Potts, Betty Renwick, Carla Winchester, Ev Zytveld (M&P) and Harry Bender (M&P). This team reviewed and updated the job description and participated in the interviews of candidates. The candidates deemed qualified from the interview process, were then asked to come and conduct a Rehearsal Audition with the full choir in late June and early July. Based on the results of the interviews, the auditions, and reference checks, the search team recommended offering the position to **Noah Landers**. Noah is a recent graduate from the University of Ottawa and has been playing organ and piano in churches since he was 12 years old. Council approved this recommendation at a special meeting on August 21. Thank you to the search team and the choir. Noah joined us September 1 and has been well received by the choir and the congregation. *Thank you, Noah, for your energy, your enthusiasm, and your commitment in leading City View's music program*.

The Drew Shouldice Bursary was presented to Liam Johnston on June 30, 2019 by Rev. Dr. Karen Boivin during the church service.

- **Memorials**: The Memorial Fund received just over \$9K in new donations in 2019, but no significant expenditures were made. The Trustee Policy respecting administration of the Memorial Fund was revised and accepted in principal by Council. The revised policy clarifies the respective roles of Council and Trustees; provides better direction on seeking out memorial projects; and provides direction on how Council and Trustees may deal with accumulated surpluses if they should become unreasonably large.
- **Rentals**: The day-to-day administration of the use and rental of Church space is ably managed by Mary Lynne Harvey. A new schedule of rental rates for casual and short-term rentals was developed in October 2018 and implemented January 1, 2019.

The Seventh Day Adventist Church are all but *full-time-part-time* tenants for the west upper hall, Room 1 – (former Presbytery & Conference space) and in their second year renting from us. They occasionally rent space for other meetings and special events throughout the year.

Our gross rentals for 2019 was: \$47,969.00

C.8 Eastern Ontario Outaouais Regional Council

The newly created Eastern Ontario Outaouais Regional Council met twice during 2019. The initial meeting was held on June 7 to 9 in Smiths Falls, Ontario; the fall meeting was held in Prescott, Ontario on October 5, 2019.

During 2019, the EOORC Finance committee completed the funds transfers from the former Upper Valley Presbytery, Four Rivers Presbytery, Seaway Valley Presbytery, Ottawa Presbytery and Eglise Saint-Marc from the Consistoire Laurentian.

The new EOORC has now access to a Mission Strategy fund of over \$1.5 million which generates an annual budget for grants to Regional communities of faith and ministries through the Vision and Transformation Ministry Team. There is a Church Extension Fund with over \$4 million in capital to provide grants and loans to communities of faith and ministries on property matters. There are also Youth Funds of nearly \$1 million in capital, generating an annual \$40,000 to support youth ministry.

The main focus of EOORC in 2019 was to confirm and setup new Governance rules to bring the 4 former Presbyteries together on the same wavelength. This process will continue if necessary, to reflect changes in our church lives. The next meeting of EOORC is on February 22, 2020 at Glen Cairn United Church in Kanata. The AGM for EOORC is scheduled for May 1 and 2 in Cornwall, Ontario.

The City View United Church representatives were Jim Watchorn and myself, Ev Zytveld as lay members and Rev Dr Karen Boivin, Rev Ann Montgomery as clergy representatives. Our attendance was greatly augmented from time to time by Dr. Charles Knight and Rev Stan Parkhouse.

D FINANCIAL REPORTS

The Financial Statements for the Year Ended December 31, 2019 and the Operating Fund and Building Repairs and Improvement Fund Budgets for 2020 are presented for your consideration on the following pages.

The Operating Fund, with revenues totaling \$268,305 and expenditures of \$267,177, ended the year with a surplus of \$1,126, compared to our projected deficit of \$29 thousand. Avoiding the deficit was due almost entirely to the lower Ministry and Personnel costs arising from the retirements of our Minister and our Choir Director and the part-year vacancy of the Youth Coordinator position, since our PAR and envelope givings were nearly \$10 thousand below our target. Fortunately, increased rental income offset the decline in givings.

The Building Repairs and Improvement Fund recorded a surplus of \$5,523 for the year, as givings allocated to the Building fund (\$13,250) were above our budget target (\$12,000). No major repair or renovation projects were undertaken during the year and our expenditures (\$7,727) were in line with our budget provision of \$8,000.

The proposed Operating Budget for 2020 projects total revenues of \$256,000 and expenditures of \$283,000, which would result in a deficit of \$27,000. The income projections are based on a "status quo" assumption, namely, that the downward trend in PAR and envelope givings will continue, that the space vacated by the Conference/Presbytery staff will not be fully rented during the year (or that fit-up costs will offset rental income if a full-time tenant is found) and that bazaar and other revenues will be maintained at current levels. The expenditure projections reflect the hiring of our new Minister, and assume that there will be no other significant changes in staffing or programs.

The proposed budget for the Building Repairs and Improvement Fund projects a surplus of \$3,000 (revenue of \$12,000 and expenditures of \$9,000), based on the assumption that no major repair or renovation projects will be undertaken during the year.

The combined Operating/Building fund budgets project an overall deficit of \$24,000, which would be financed by drawing on our accumulated reserves.

I would like to thank our Bookkeeper, Veronica Moore, for her continuing support in preparing our financial statements, and members of Council for their valuable advice and assistance in developing the proposed 2020 budget.
